FIRST AMENDMENT TO DECLARATION OF CONDOMINIUM OF HARBOR CLUB, A CONDOMINIUM

- 1. Add six (6) Boat Slips and other appurtenant improvements more specifically described on Exhibit "D" attached to this amendment.
- Amend Article X, Use Restrictions by adding the following:
 - Q. No fish cleaning will be allowed on the docking facility. All fish cleaning must occur on the uplands and fish remains must be disposed of in a trash can. One sign will be maintained on site as depicted on the attached Exhibit "D". The sign will read "No Fish Cleaning Allowed on Dock".
 - R. The maximum draft, with the motor in the down position has been determined for each Boat Slip and is stated below to allow sufficient clearance between the boat and the submerged aquatic resources. A sign will be maintained on the waterward face of the bulkhead as depicted on the attached Exhibit "D" reading; Draft: Boat Slips 1, 2, 5 and 6-22"; Boat Slips 3 and 4-20"."
 - S. Solar-powered lights, to be illuminated at night, will be maintained on the most waterward pilings of the facility to aid boaters with navigation.
 - T. A sign will be maintained on the waterward face of the dock. The sign will read "No Wake Within 500".
 - U. No mooring will be permitted south of the northern six (6) Boat Slips due to seagrass beds in the area and such additional mooring area would exceed the Manatee Protection Plan requirements, until a method of protecting the seagrass beds and Manatees is submitted to the applicable governmental agency, which is presently St. Johns River Water Management District, and approved by the agency.
 - V. A Manatee information sign will be maintained on the dock at all times.

All other terms, conditions and provisions of the Declaration of Condominium and exhibits thereto shall remain in full force and effect and unchanged except as set forth herein.
